I, Michael McCurdy, declare as follows:

- I am the named plaintiff in the above-captioned action. I submit this declaration in 1. support of Plaintiff's Motion for Preliminary Approval of Class Action Settlement. The following facts are based upon my personal knowledge and if called upon to do so, I could, and would, competently testify thereto. I reside in Alexandria, Minnesota.
